071012.31 First Hill Streetcar
Briefing by Ethan Melone, Seattle Department of Transportation (SDOT), on proposed Street Use and Design for the First Hill Streetcar. This briefing will cover the alignment along S. Jackson Street from 4th Ave. S. to 12th Ave. S. Discussion will include an overview of right-of-way modifications including proposed platform and shelter design, curb revisions, and location of the tracks and poles.
